BIDDING PROCEDURES TO KEEP IN MIND:

1. All bidding is open and public. You or your authorized representative must be registered and approved to bid.
2. The online and in-person auction will begin Friday, October 28th, at 1:00 PM CDT. The property will be offered in 4 individual tracts using the “Buyer’s Choice” method of sale, whereas the high bidder can purchase any individual tract or combination of tracts for their high bid. Should the high bidder not select all available tracts, the remaining tracts will be offered with another round of bidding. This process will repeat until all parcels have been chosen by a high bidder. Bidding will be on a dollars per acre basis. The final purchase prices for these tracts will be determined by multiplying the surveyed acreage by the high bid(s).

Final surveyed acres are as follows:

Tract 1: 154.117 Acres

Tract 2: 129.489 Acres

Tract 3: 126.755 Acres

Tract 4: 39.068 Acres

Total: 449.429 Acres

3. YOUR BIDDING IS NOT CONDITIONAL UPON FINANCING, so be sure you have arranged financing, if needed, and are capable of paying cash at closing.
4. Minimum bid increments are at the discretion of the Auctioneer.

TERMS OF SALE OUTLINED:

1. The Real Estate Purchase Contract is available for review both in the bidder’s packet and on the Murray Wise Associates website. **It is the responsibility of each bidder to review this information prior to the start of the auction.** All successful high bidders will enter into a Contract to Purchase immediately following the close of bidding for presentation to the seller. Final bid price is subject to approval or rejection by seller. Upon the close of the auction the winning bidder will sign the Contract to Purchase in DocuSign.
2. Ten percent (10%) of the purchase price will be due as a non-refundable down payment within 24 hours of the close of the auction. The down payment will be paid in the form of wire transfer and held by Jackson County Abstract & Title Guarantee Co.
3. The balance of the purchase price will be due at closing which shall be held on or before November 29, 2022 or as soon as the title company will allow. Closing requirements will be as specified in the Real Estate Purchase Contract. Seller shall deliver full possession of the property to Buyer at closing, subject to remaining rights of the current tenant under the 2022 crop lease.

4. Seller shall furnish the Buyer, at Seller's expense, an Owner's Policy of Title Insurance in the amount of the purchase price after closing and shall provide a properly executed Warranty Deed conveying the property to the Buyer(s) at closing.
5. The 2022 calendar year taxes due and payable in 2023 shall be paid by the Seller in the form of a credit at closing. The most recent tax figures available will be used to determine the amount of the credit. The 2023 calendar year taxes and beyond will be the responsibility of the Buyer(s).
6. The Seller will retain all income from the 2022 crop.
7. The sale of property shall include all mineral rights owned by the Seller, if any.
8. The sale shall not include any personal property.
9. The Auction Company has made available on its website such documents as tax bills, Real Estate Purchase Contract, aerial photographs, etc. **It is the responsibility of each bidder to review this information prior to the start of the auction.**
